THE INCONVENIENCE IT MUST HAVE CAUSED TO THE CBW TEAM. THE INFORMATION CONTAINED IN REF C. WAS EXTREMELY HELPFUL AND WE LOOK FORWARD TO RECEIPT OF THE DOCUMENTATION MENTIONED. THE TEAM DID AN EXCELLENT JOB WHICH WE APPRECIATE. WE DEFINITELY WOULD LIKE TO HAVE FOLLOW-UP BIOMEDICAL SAMPLES OF THOSE INDIVIDUALS AVAILABLE FOR RECONTACT AS WELL AS AGE AND SEX MATCHED CONTROL BIOMEDICAL SAMPLES FROM INDIVIDUALS RESIDING IN THE BAN VI <sup>N</sup>AI CAMP.

2. THE ANALYSES<sup>E</sup> OF SAMPLES FROM THESE INDIVIDUALS HAVE BEEN COMPLETED AND SOME HAVE TESTED POSITIVE. AT PRESENT, DETAILS ARE CLASSIFIED CONFIDENTIAL/NOFORN. DUE TO THE FACT THAT KNOWLEDGE OF THESE RESULTS MAY BIAS THE INTERVIEWER, WE PREFER THAT RECONTACT AND FOLLOW-UP INTERVIEWS BE CONDUCTED BEFORE THE RESULTS ARE RELEASED. THIS WILL ENSURE THAT ALL THOSE INTERVIEWED ARE TREATED SIMILARLY. WE REALIZE THIS PLACES A GREATER BURDEN ON THE TEAM BUT WE FEEL IT IS A NECESSARY ONE. WHILE THIS INTERVIEWING IS TAKING PLACE WE WILL TAKE THE NECESSARY STEPS TO GET THE RESULTS DECLASSIFIED SO THAT THE RESULTS CAN BE RELEASED TO THE ROYAL THAI GOVERNMENT, THE VICTIMS, AND THE COLLECTORS IMMEDIATELY AFTER THE RESULTS OF THE RECONTACT ARE RECEIVED BY AFMIC.
